


1. The National College Council running and seeking CBSE affiliation is an organization of non – proprietary character.
2. It has been Registered as a society under the Societies Registration Act of 1860 and now governed by Tamilnadu Societies Registration Act 27 of 75. The said act prohibits any sort of appropriation of the society funds by the individual members while its functioning or on its desolution.
3. By an order in C.No.935(10)CCIT/TRY/2008-09 dated 30/12/2009, the Society has been granted approval u/s 10(23C)(vi) of the Income-tax Act by the Chief Commissioner of Income tax, Tiruchirappalli . The Society has also been granted registration u/s 12AA of the Income-tax Act by the Commissioner of Income tax-I, Tiruchirappalli vide order in C.No.6162E(93)/2000-2001 dated 07/01/2002.
4. Further, the society has also been granted approval under section 80 G (5) of the Act. These facts show that the non - proprietary character of the society.
5. As Secretary, I hereby affirm that the society National College Council registered as Society No.3 / 1908 – 1909 functioning under the jurisdiction of the Registrars of Society, Tiruchirappalli is of non proprietary character.

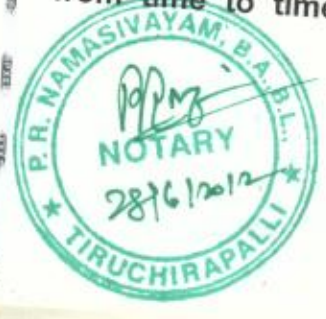
